In accordance with the authority granted by the Law on Water, Wastewater and Waste no. 03/L-086, dated on June 15, on the Activities of Water and Waste Providers, which was amended by Regulation 2004/49 (the Law).

In conformity with Article 15 for *Determination of Service Tariff for Water, Wastewater and bulk water supply in Kosovo*, dated on December 24, 2012. (Rule of WWRO- R 02/M) and the Tariff Policy dated 18 March 2014.

Based on the application data for the Service Tariff for the bulk water supply submitted by the HEE "Iber Lepenc" J.S.C Prishtina, and in the process of analysis review and evaluation,

Water and Waste Regulatory Office ("WWRO") with its authority, issues the following:

SERVICE TARIFF ORDER

FOR DETERMINATION OF UNTREATED BULK WATER WHICH SHOULD BE APPLIED BY HEE "IBER LEPENC" J.S.C PRISHTINA FOR SUPPLY OF RWC "MITROVICA", J.S.C, MITROVICA AND RWC "PRISHTINA" J.S.C., PRISHTINA,

TARIFF PERIOD 2015-2017

1. Interpretation

In this Service Tariff Order (STO), unless the context requires differently, the words and phrases with capital letters shall have the meaning attributed to the Rule of WWRO- R 02/M.

2. Implementation

This Service Tariff Order is applicable and binding for the HEE "Iber Lepenc" J.S.C, and upon billing of services with Untreated Bulk Water for two Regional Water Supply Companies, respectively for RWC "Mitrovica" J.S.C, and RWC "Prishtina" for Unit of Drenas.

WWRO may make corrections and extraordinary service tariffs based at the request of the HEE "Iber Lepenc" J.S.C, in accordance with Article 15. and 16. of the Rule WWRO R-02/U&K.

3. Service Tariff Overview 2015-2017

HEE "Iber Lepenc" J.S.C, Prishtina, for its customers to apply the Service Tariff for untreated bulk water supply during the three (3) years of tariff period 2015-2017 as is given in table below:

4. Application deadline

Tariffs for 2015 will last a calendar year and shall be applied according to the table above which are mandatory for billing, starting from 1 January 2015 until 31 December 2015.

The tariffs set forth in these STO are without VAT

5. Procedures of tariff review

Tariffs applied for 2016 and 2017 may be reviewed for determination and application during relevant years in accordance with the WWRO Regulatory acts, taking into consideration the degree inflationary movements of Customary Price Index in Kosovo, published by Kosovo Agency of Statistics for the viewed period.

- 1. for 2016, inflationary period viewed from: December 2014- November 2015, and
- 2. for 2017, inflationary period viewed from: December 2015- November 2016, and

5. Publication and Distribution of Services Tariff's List

HEE "Iber Lepenc" J.S.C, Prishtina is obliged to notify the Regional Water Companies, which supplies with untreated bulk water with Service Tariffs determined by WWRO, under this Service Tariff Order, upon signing of the contract for services or to send same copy of its next bill, after its promulgation and publication of the WWRO in its internet portal: www.wwro-ks.org.

6. Appeals

HEE "Iber Lepenc" J.S.C., has the right to appeal this order or its part within 15 calendar days from its date, in case of disagreement with this STO, to the Review Committee established under section 34.of the Review Committee, Section 34.1., Law no. 03/L-086 on the *Activities of Water, Wastewater and Waste Service Providers*, dated on June 15, 2008,

7. Official language of the Tariff Directive.

This Service Tariff Order is published in three (3) written language versions of which two (2) are official languages used in Kosovo as:
