Pursuant to the authority granted by the article 19, paragraph 1 of the Law no. 05/L-042, on the *Regulation of Water Services*, as published in the Official Gazette no. 4/2016, date 14.01.2016 (“the Law”), and conform article 15 of the WSRA Rule no 07/2016 on the Determination of the Water Service Tariffs in Kosovo, date 23 September 2016.

Based on the data of the Service Tariff application submitted by RWC “Prishtina”, J.S.C., for the 2018-2020 tariff process.

The Water Services Regulatory Authority (WSRA) issues this:

## **SERVICE TARIFF ORDER**

**TARIFFS FOR WATER AND WASTE WATER SERVICES THAT SHOULD BE APPLIED BY RWC “PRISHTINA” J. S. C., PRISHTINA FOR THE PERIOD 01 JANUARY 2018 – 31 DECEMBER 2018 FROM TARIFF PROCESS 2018-2020**

### **1. Interpretation**

In this Service Tariff Order (STO), unless the context requires differently, the words and expressions with capital letters shall have the meaning attributed to the Rule of 07/2016.

### **2. Applicability**

This Service Tariff Order is applicable and enforceable to RWC “Prishtina” J.S.C., upon billing of Water and Wastewater Services that provides to its customers throughout its designated Service Area.

WSRA can make regular and exceptional adjustments of Service Tariff, based on request of RWC “Prishtina” J.S.C., in compliance with section 16 and 17 of the Rule 07/2016.

### 3. Content of the STO Appendixes

Annexes to this Service Tariff Order include:

The tariffs determined under this STO are without VAT.

### 4. Timeline

Service Tariffs determined under this Service Tariff Order shall be applicable for the period, respectively from January 1, 2018 until December 31, 2018.

### 5. Publication and Distribution of Service Tariff List

5.1 RWC "PRISHTINA" J.S.C. should distribute the Service Tariff List as approved under this (STO) to each customer upon signing the Service Contract, or at least once at the beginning of its application to attach it with the invoice, by which customer are billed.

5.2 The Service Tariff List approved by WSRA under this Service Tariff Order shall be published by the RWC "PRISHTINA" J.S.C., at least on one of the daily newspapers with the comprehensive general circulation throughout Kosovo, within seven (7) business days after announcement and publication of WSRA on its official website; [www. arru-rks.org](http://www.arru-rks.org).

### 6. Appeals

RWC "PRISHTINA" J.S.C has the right to appeal this order or its parts within one month since the date of publication to the Review Commission which was established under the section 41, the Review Commission, Law no. 05/L-042 on Regulation of Water services, published on Official Gazette no. 4/2016.

### 7. Official Language of Service Tariffs Order

This Service Tariff Order (STO), is issued and published in three (3) languages, two of which are official languages used in Kosovo, and in English Language.

In case of discrepancies between of any of the versions of STO, the Albanian language shall prevail.
